WELCOME

Thank you for your interest in joining the Calderstones Mansion House Community Interest Company (CIC) Board of Directors. The Reader Group consists of The Reader Charity and the CIC.

The Reader is a national charity that uses the power of literature and reading aloud to transform lives. Our Shared Reading model brings people together creating powerful moments of connection.

Social enterprise has always been at the heart The Reader and the ability to generate commercial revenue at Calderstones is absolutely essential to the sustainability of the site and indeed The Reader.

The CIC also provides Social business value through a number of different ways. Simply put, we exist to:

- Improve wellbeing through a creative community and the power of Shared Reading
- Demonstrate how a creative model of health improves social connection and wellbeing
- Generate our own income to support The Reader and provide meaningful employment and volunteering

Income is currently generated through our social enterprise activity at Calderstones, namely The Reader Ice Cream Parlour, The Reader Café, The Reader Bookshop and our events business.



The Calderstones Community Interest Company has three goals:

- To provide services that are valued in the community and contribute to the mission of The Reader Charity
- To provide meaningful opportunities for employment and skills, particularly for those who need it most
- To provide a sustainable unrestricted source of income to support The Reader's primary purpose

Could you help The Reader further its mission and build its social enterprises? We are looking for two new independent Directors of the Calderstones Mansion House Community Interest Company and are particularly interested to hear from people with experience of values led organisations. You do not need to live locally to Calderstones Park in Liverpool and travel expenses will be provided. However, a knowledge and connection with the wider Liverpool City Region is vital. The roles are unremunerated and require a three year commitment in the first instance.

What you'll be getting up to:

- Providing expert support and advice to the Directors Group on behalf of the Board and supporting the work of the organisation wherever you can.
- Attending all CIC Board meetings, which are crucial to the sound governance of the CIC (usually four per year). This gives you a chance to regularly come to the site and see for yourself how things are going and chat to staff and volunteers in person.
- Ensuring that there is a strong and ambitious strategic and business planning framework in place.
- Ensuring a sound financial and budgetary framework.
- Actively reviewing and overseeing the management of risk supporting the Directors Group in making sure that the good things do happen and that the bad things don't.
- Monitoring the effectiveness of the CIC in relation to all our plans.
- You'll have access to all our publications and literature and you'll be more than welcome to attend our Think Days (staff engagement events) and other programmed events.

Other things it might be helpful to know

The recruitment opportunity has arisen due to two Independent Directors retiring from the Calderstones Mansion House Community Interest Company Board to join The Reader's Board of Trustees.

Operational decisions at The Reader are delegated to The Managing Director, Jemma Guerrier, the Director of Social Enterprise Anton Clarke and the Directors Group.

The Reader has a long term 125 year lease from Liverpool City Council for Calderstones, which includes the following buildings: Storybarn, Coach House and related courtyard outbuildings, potting sheds, Mansion House and car park adjacent to the courtyard. The current Directors on the CIC Board are Anita Marsland (Chair), Pranav Sood, Phillip Davies, Sarah Fletcher, Virginia Hopton, Pauline Hughes and Kelly Spells. The role of the CIC Directors is a strategic one. Directors are responsible for the sound governance of the CIC. For your assistance, you will be provided with the CIC's governance pack which sets out and gives explanatory notes in relation to the CIC's governance documentation, including all significant policies, and the CIC Business Plan.

What we'll expect of you:

- Uphold the values and objectives of The Reader.
- Familiarise yourself with our work, and actively support the leadership team.
- Prepare for, attend and fully contribute to meetings of the Board; treating all other contributions with respect.
- Participate in sub-committees where needed.
- Be an ambassador for The Reader all times.
- Declare any relevant interest.
- Respect confidentiality of information.

What you can expect from us:

- Induction and other specialist training, as appropriate.
- Plenty of notice of the annual schedule of Board Meetings.
- Administrative assistance with, and advice about matters associated with your role as a Director.
- Agendas and meeting papers circulated a week in advance of meetings.

Limited amounts of Trustees' and Directors' personal data (e.g. address, date of birth) will occasionally need to be shared with other organisations we are registered with, or apply to use services from, in order to fulfil identification verification requirements and comply with anti-money laundering checks. This information would only be shared for these limited purposes and only with organisations we are satisfied are fully compliant with UK GDPR.

WHAT SHARED READING DOES

"It's about feelings. It's about reading something and saying 'that's just made me feel this' - it's about connection. That's what happens in the room in between the story."

If you're new to literature or not, the impact of getting together and connecting through reading aloud, whether a book or poem, is at the heart of everything we do. In contrast to traditional reading groups, in our Shared Reading sessions the reading takes place within the groups themselves, rather than in advance. The liveness of the reading opens up space for new thoughts to emerge and new connections to be forged. We read with school groups, families, adults, looked after children, older people in care homes, adults with physical and/or mental health conditions, people coping with or recovering from addiction and individuals in the criminal justice system.

We know that our work is helping to improve wellbeing, reduce isolation and build stronger communities. We offer the opportunity for all those who work or volunteer with us to experience and benefit from Shared Reading. It is open to all and you don't need to be academic or have previous experience with literature. You might be surprised at what Shared Reading can do for you too.

How to apply

Candidates should submit their CV alongside a covering letter that articulates how their experience connects to the job description and role requirements. Please send this to laurakershaw@thereader.org.uk by Friday 28 June 2024. Unfortunately, if we receive a high volume of applications, we may not be able to reply to everyone individually.

Equal opportunities

We are committed to attracting diverse candidates. Applicants who meet our minimum (essential) criteria and identify as one of the following will be guaranteed an interview: Black, Asian and Minority Ethnic, LGBTQ+, those with disabilities, those with unconventional life experience or educational background.

Selection process

If successful at shortlisting, you will be invited to interview. We will keep you informed of our expectations during the process but please note that these interviews will be conducted on site at Calderstones rather than remotely.

Attending the interview

We will cover travel expenses for anyone who is not currently in a position to do so. If you need any more information on the format of the interview, who will be interviewing, and what to expect on the day, please contact laurakershaw@thereader.org.uk.

An offer of appointment to the position of Director to the Calderstones Mansion House Community Interest Company Board is conditional upon receipt of two satisfactory professional references. Referees will be sought from an applicant once an offer of appointment is made. A basic DBS check will be undertaken as part of the induction process.

If you have any special requirements, please let us know in advance and we will be happy to make any adjustments needed.

Key dates

Closing date for applications is Friday 28 June 2024. The shortlisting process begins the week commencing week commencing 1 July 2024.

Interviews will take place in the week commencing 22 July 2024.

We will ask Candidates to visit the Calderstones site to:

- Participate in a Shared Reading session with a group of staff members (40 mins)
- Take a site tour with the Director of Social Enterprise (30 mins)
- Attend a panel interview (60 mins)

Successful candidates will:

- Meet with the Chair of the Calderstones Mansion House CIC Board.
- Receive an in-person induction session at Calderstones Mansion House, including receiving key governance documents and completing a basic DBS check.
